Ashley- talked to Don Patterson- they approved the Small Fry Classes- she also gave him some clarifications on the Level 1 W/T- they do have another meeting coming up.

The BOD Needs to look at revising the per class fee increase voted on at Jan meeting-Scott had sent an email to consider revising the per class fee change.

Discussion- Scott-this became a real number over quite a few judges, 2 or 3 horses, multiple shows throughout the summer.

Ryane/Kristy- why were fees decreased for the all arounders, but increased for the little people? (halter, reiners, etc)

Jenna- MN Shows- \$15 per class- pretty much everyone is at that fee- FYI-

Jessie- It is more about the principle of it- we are in a good financial position and if it fosters good feelings, we should go back.

Jessie- Motion to revert back to same class fees as last year (2015) in the interest of good faith and fostering good feelings throughout our association, \$12 open & Amateur, \$9 Novice and Youth Kristy- second

Jessie- was approached by a member who had an idea about bringing in a pro horseman clinic- potential way to make money- possibly an item to put on the agenda for April and to look into further.
